In 2005, the Women's Division of the United Methodist General Board of Global Ministries launched a program activating local United Methodist Women members to work on environmental issues in their communities.

After a three-month application process, 24 United Methodist Women members, including one male pastor, were selected for the Green Team program.

The Green Team advocates for environmental justice, the fair treatment and involvement of all people—regardless of race, ethnicity or economic status—in the decision-making process on environmental public policies. For people who are marginalized, Green Team members listen to them and voice their concerns.
